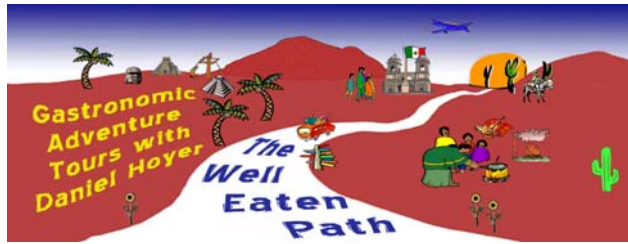

Validity

The prices listed are based on the costs and exchange rates current at the time of printing. **WELL EATEN PATH-CHEF'S TOURS** reserves the right to alter these prices at any time. For trips departing between 01 January 2008 and 31 December 2008, the land price of your trip is guaranteed when you have paid in full (*the receipt of local payment, if required, is not needed to guarantee a price*).

Payment Schedule-

Total price \$3,095/person, Dbl occupancy, \$825 single supplement

Deposit- \$300 per person. Due with application by January 10, 2008

Interim payment- \$1,400 per person (\$1,825 for single supplement). Due January 30, 2008

Final advance payment- \$1,195 per person. (\$1,595 for single supplement) Due February 22, 2008

Local payment- \$200 per person. Paid upon arrival in Vietnam

Cancellation by the traveler

Retention of monies paid applies to all cancelled reservations. The date of trip cancellation is the date on which the written cancellation is received by **WELL EATEN PATH-CHEF'S TOURS**

• The retention of monies paid is as follows, per person:

- 120 days or more prior to trip departure
 - Loss of deposit
- Between 90 and 120 days prior to trip departure
 - 50% of total booking cost
- Between 45 and 90 days prior to trip departure
 - 75% of total booking cost
- Less than 45 days prior to departure
 - 100% of total booking cost

No refunds will be made if you voluntarily leave a trip for any reason after the trip has begun. Refunds will be at the discretion of **CHEF'S TOURS** if you are involuntarily forced to leave a trip for any reason. No refunds will be made for any accommodation, transport, sightseeing, meals or services not utilized.

*Please note that these conditions apply to **WELL EATEN PATH-CHEF'S TOURS** land content only.*

Cancellation by **WELL EATEN PATH-CHEF'S TOURS**

WELL EATEN PATH-CHEF'S TOURS reserves the right to cancel any trip before it is guaranteed to run. This trip is guaranteed to run once 8 participants are fully-paid. Any monies paid prior to a cancellation by **WELL EATEN PATH-CHEF'S TOURS**, of a trip not guaranteed, will be refunded. Additionally, **WELL EATEN PATH-CHEF'S TOURS** reserves the right to cancel any trip, including a guaranteed trip, due to terrorism, natural disasters, political instability or other external events which make it unviable for **WELL EATEN PATH-CHEF'S TOURS** to operate our planned schedule. In such a case, **WELL EATEN PATH-CHEF'S TOURS** will, at its own discretion, refund the trip price only.

Booking amendments

If you wish to change your booking in any way, the following fees will apply:

1. Changes to tour bookings;

- If the booking amendment request is received by **WELL EATEN PATH-CHEF'S TOURS** 90 days or more prior to your original tour's departure —US\$100 per person, per change;
- If the booking amendment request is received by **WELL EATEN PATH-CHEF'S TOURS** less than 90 days prior to your original tour departure date — charges as per cancellation fees.
- If there has been any change in the price of the tour you change your booking to, since the time of your original reservation, the new tour price will apply to the new reservation.

These fees are in addition to any charges levied by hotels, ground operators or airlines.

2. Changes to any other arrangements made in conjunction with your tour booking (e.g.: hotels, transfers, etc.)

• Amendments to any other arrangements made in conjunction with your tour reservation will incur a US\$50 administration fee per booking per change. This fee is in addition to any charges levied by hotels, ground operators or airlines.

3. It may not be possible to make any amendments to your booking within 30 days of departure.

Insurance

Medical travel insurance or evidence of valid existing coverage is **mandatory** for all **WELL EATEN PATH-CHEF'S TOURS** travelers. This is to protect you and also protect your fellow travelers from interruption to their trip due to an unforeseen accident or illness. Your travel insurance should provide coverage against personal accident, medical expenses, emergency repatriation and personal liability. We also recommend that it cover cancellation, curtailment and loss of luggage and personal effects. Your current health coverage may apply. You will be asked to provide proof of medical, accident and evacuation coverage prior to commencing the trip

Passports and Visas

You must carry a valid passport and have obtained the appropriate visas when traveling with **WELL EATEN PATH-CHEF'S TOURS**. Please ensure your passport is valid for 6 months beyond the duration of the trip. It is your responsibility to ensure that you are in possession of the correct visas for your holiday. **WELL EATEN PATH-CHEF'S TOURS** cannot accept responsibility if you are refused entry to a country because you lack the correct visa documentation.

Responsibility

You acknowledge that travel on a **WELL EATEN PATH-CHEF'S TOURS** trip requires a degree of flexibility, and understand that the trip's route, accommodation and modes of transport are subject to change without prior notice due to local circumstances. Should **WELL EATEN PATH-CHEF'S TOURS** deem it advisable to amend an itinerary for any reason, it may do so by shortening, varying or re-routing any trip. These changes are binding and while traveling with **WELL EATEN PATH-CHEF'S TOURS** you agree to accept the authority of the leader and local operator at all times. You are aware that travel within a group may involve compromise to accommodate the diverse desires and physical abilities of group members. You understand that **WELL EATEN PATH-CHEF'S TOURS** reserves the right to decline, accept, or retain any person as a member of the group at any time. You acknowledge that **WELL EATEN PATH-CHEF'S TOURS** contracts on your behalf with a network of companies, government agencies and individuals to assist in the running of its tours. To the best of **WELL EATEN PATH-CHEF'S TOURS'** knowledge, these third parties are qualified to perform the duties they are contracted to perform. However, **WELL EATEN PATH-CHEF'S TOURS** will not be held liable for any injury, damage, loss, delay or irregularity that may occur due to the behavior of these third parties. **WELL EATEN PATH-CHEF'S TOURS** will not accept responsibility or liability for any traveler who contravenes any law or regulation of any country visited. No employee, servant or agent of **WELL EATEN PATH-CHEF'S TOURS** has authority to vary these conditions. This agreement is governed by the laws of the State of New Mexico

Participation form

All **WELL EATEN PATH-CHEF'S TOURS** travelers must sign a Participation Form on Day 1 of the trip. Please note that signing the form is a pre-requisite of traveling with **WELL EATEN PATH-CHEF'S TOURS**. The wording of this form follows:

*"I understand that traveling with **WELL EATEN PATH-CHEF'S TOURS** may involve risks (and rewards) above and beyond those encountered on a more conventional holiday, and that I am undertaking an educational/adventure trip that could include some risks. I understand that I am traveling to geographical areas where, among other things, the standard of accommodation, transport, safety, hygiene, cleanliness, medical facilities, telecommunications and infrastructure development may not be of the standard I am used to at home or would find on a more conventional holiday. I have read and understood the **WELL EATEN PATH-CHEF'S TOURS** itinerary for the trip I am undertaking and have provided details of any pre-existing medical conditions I have to **WELL EATEN PATH-CHEF'S TOURS** representatives. I accept these risks and obligations and I fully assume the risks of travel. I release **WELL EATEN PATH-CHEF'S TOURS** from any liabilities connected to these risks to the maximum extent permitted by law."*
